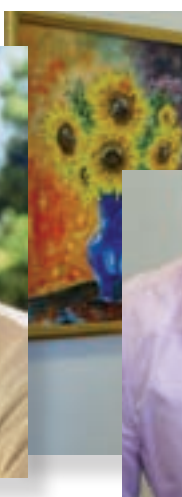

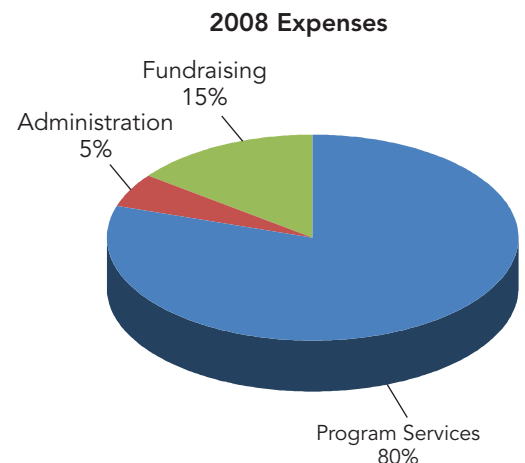
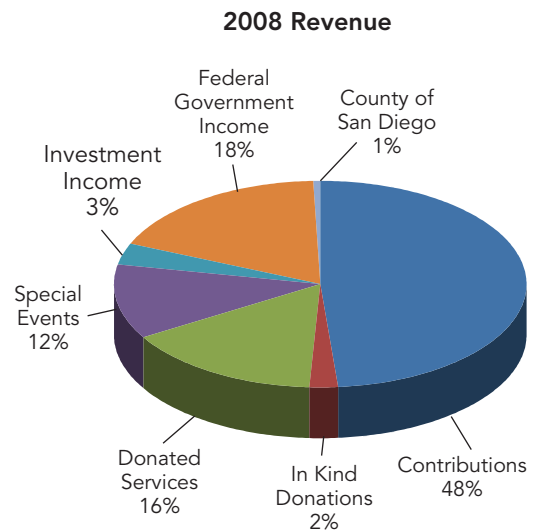

RACHELLE CARVAJAL

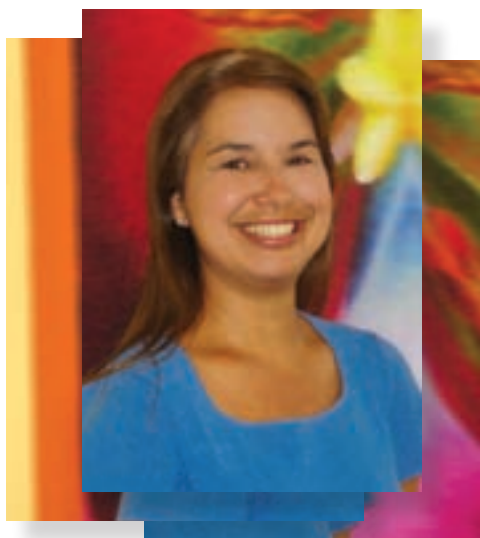
