### MESSAGE FROM OUR EXECUTIVE DIRECTOR AND BOARD PRESIDENT

This report covers the period from July 1, 2017 to June 30, 2018. It's been 12 months of changes...evolution. And one of the most fundamental and transforming changes is informed by the Food is Medicine paradigm.

In May, 2017, the board of directors expanded our mission to serve people with other critical illnesses, while affirming our continued commitment to the nutritional needs of people with HIV or cancer.

In April, 2018, Mama's Kitchen started participating in a state-wide pilot project to provide medically-tailored meals to Medi-Cal recipients living with congestive heart failure. The goal of this pilot is to demonstrate to the state of California that medically appropriate nutrition can improve health and reduce healthcare costs.

With the permanent elimination of any age cap for people with cancer, Mama's Kitchen started providing services to people with cancer over the age of 65. By June, 2018 we had added 34 clients with cancer (a 20% increase).

During this period Mama's Kitchen shifted its efforts to prepare more meals from scratch. As a result menus were dramatically improved by our executive chef, Jason Martin, and our registered dietitian, Stephanie Boyd.

Overall, many hundreds of San Diego residents living with the challenges of HIV, cancer, and congestive heart failure were nutritionally supported with over 319,000 meals; some 5,346 pantry visits for our clients with HIV; and hundreds of hours of nutritional assessments, counseling, and education.

Your support of our fundraising efforts, including Mama's Day and our Mama's Pies Sale, was critical in the provision of nutritious food and education to over 1,300 San Diego county residents living with critical illnesses and vulnerable to malnutrition.

As important was your volunteer engagement: cooking and packaging fresh, healthy, medically tailored meals, driving tens of thousands of miles throughout the county to deliver these meals, staffing Mama's Pantry, volunteering at our fundraising events, staffing our front desk, and supporting other critical areas of operation.

Your involvement with Mama's Kitchen makes you, more than ever, an agent for healing our community through nutrition. Nutrition that is medically appropriate, fresh and flavorful, and a profound statement of love for and commitment to our San Diego County community.








